Overview of NGO Action Week:

The NGO pre-summit, taking place from October 12 to 16, 2026, represents a pivotal moment for civil society's involvement in global social development efforts. This event seeks to generate momentum for a renewed and collaborative approach among NGOs, emphasizing the creation of a more inclusive and sustainable community in the wake of the 30th anniversary of the Copenhagen Declaration.

To maximize the impact of the Summit, the Chairperson of the NGO Coalition for Social Development and the Director of the NGO Affairs Agency, TANGO The Gambia, are jointly overseeing the NGO Action Week. Their leadership will facilitate a global gathering of NGOs at the SDK International Conference Center in Senegambia, The Gambia. The initiative is centered on presenting a cohesive civil society voice in summit discussions, fostering forward-looking strategies and broad inclusivity. Furthermore, the event will provide opportunities for civil society to directly engage with representatives from UN agencies, Member States, Intergovernmental Organizations, and other stakeholders following the Second World Social Summit (SWSS) in Doha, Qatar, 2025.

The Action Week features several key events, including the NGO Mobilization Day on Monday, October 12, and the Social Development Action Week spanning October 12 to 16 at the SDK International Conference Centre. The agenda will consist of plenary sessions and breakout groups focused on critical issues relating to NGO engagement. These sessions are designed to encourage active participation from members, state and party representatives, and honored guests, thereby ensuring that grassroots perspectives and civil society feedback are incorporated into discussions on the Doha outcome political declaration for social development. The workshop will be conducted in English and will be accessible by invitation only.

The five-day workshop is structured to produce a comprehensive civil society framework of action. This framework will guide ongoing and future efforts by NGOs to advance social development and shape policy outcomes. A structured mechanism to monitor, evaluate, and report government progress on commitments to the 2025 Doha Outcome. A recurring platform for dialogue, knowledge exchange, advocacy coordination, and global solidarity. New partnerships and collaborations have been formed to support ongoing social development processes. Participants are equipped with tools, strategies, and a shared understanding to influence national and global social development agendas. Consolidated civil society input to inform regional and global policy discussions, including future World Summits on Social Development.

The NGO Acceleration Day is set to demonstrate that transformative progress in key areas of NGO advancement is both possible and already underway. Notable speakers and participants will include Ministers, UN Principals, and representatives from the private sector, civil society, and other relevant stakeholders. These coalitions will commit to specific, tangible actions that

align with national priorities, further strengthening initiatives and partnerships for social development.

5-DAY ACTION WEEK PROGRAM

“CIVIL SOCIETY IN ACTION: Advancing Civil Society Engagement in promoting the outcome of the 2025 Second World Social Summit for Social Development in Doha.”

Summary: Five-Day Workshop Structure and Approach

The five-day program is intentionally designed to empower NGOs and civil society actors, enabling them to take an active role in developing a comprehensive framework for monitoring and reporting on the outcomes of the Second World Social Development Summit held in Qatar. This workshop prioritizes a participatory methodology, which ensures that all attendees are directly engaged in discussions and activities tailored to their specific roles and capacities within their organizations and broader civil society efforts.

Throughout the duration of the workshop, participants will collaborate in sessions and breakout groups that foster input and exchange among diverse stakeholders. By centering the program on active involvement, the event aims to create a sense of shared responsibility and ownership over the resulting civil society framework. This approach supports meaningful contributions and collective decision-making, ultimately strengthening the mechanisms for tracking progress and influencing future social development initiatives.

Program Objectives:

- Unite civil society stakeholders in advancing social development priorities in alignment with the SWSS and the 2025 Doha Outcome.
- Develop a Civil Society Framework of Action (CSFA) to guide regional monitoring, reporting, and advocacy efforts.
- Launch “NGO-Common Space,” an annual civil society initiative designed to mobilize, connect, and amplify collective action.
- Strengthening grassroots resilience and coherence across sectors and regions by creating a collaborative platform for knowledge exchange.
- Highlight ongoing civil society initiatives and connect them with global advocacy campaigns and development processes.

Through these focused activities, the workshop seeks to reinforce the pivotal role that NGOs and civil society organizations play in shaping social development policy and advocacy at both national and international levels.

Workshop Title:

"Partnership for the Future after 30 years: Civil Society Voices in the Second World Social Summit (SWSS) Process"

Target Audience:

Representatives of civil society, non-governmental organizations, Indigenous Peoples, people with disabilities, people of African descent, youth representatives, youth-led organizations, community organizations, faith-based organizations, academic institutions, representatives of workers and employers, and the private sector, with due regard to gender balance.

Key Outputs Delivered

1. Civil Society Monitoring & Reporting Framework:

The primary outcome of this workshop is the collaborative development of a draft framework for civil society monitoring and reporting. This framework clearly outlines the overall monitoring goals and identifies priority indicators to be tracked. It also details effective data collection strategies, establishes defined roles for NGOs, networks, and community partners, and proposes mechanisms for coordination at both national and regional levels.

2. Action Plan for Implementation:

Participants reached a consensus on an initial roadmap for implementing the framework. This action plan includes the formation of a steering group responsible for finalizing and operationalizing the framework. It also involves organizing training and orientation sessions for local partners, conducting pilot testing of the newly developed monitoring tools, and setting a timeline for producing the first civil society monitoring report.

3. Strengthened Networks and Collaboration:

The workshop also played a pivotal role in facilitating the establishment of new partnerships and reinforcing existing networks. These strengthened connections enable ongoing collaboration and coordination among stakeholders in the monitoring of social development commitments.
